

Promallshop Affiliate Program – Terms & Conditions

1. Introduction

The **Promallshop Affiliate Program** allows individuals and businesses to earn commissions by referring customers through a unique affiliate link. This document outlines the guidelines, commission structure, and withdrawal process.

4. Commission Structure

Affiliates earn a commission based on product category sales. Below is the updated commission breakdown:

Category	Commission Percentage
Video Conferencing	1%
Coding and Robotics Kits	5%
Screens	4%
IP Phones	6%
VC Solutions Accessories	5%
Headsets	7%
Webcams	7%
Mouse	6%
Keyboards	6%
Phone Accessories	10%
Office Equipment	5%
Home Automation	8%
Business Technology Solutions	2%

- Commissions apply only to **successful transactions** (excluding cancellations, refunds, or fraudulent orders).

5. Payout & Withdrawal Process

- **Minimum withdrawal threshold:** ₦10,000.
- Commissions are calculated at the **end of each month**.
- Payments are processed within the **first week of the following month**.
- Payments are made via **bank transfer** to the affiliate's registered account.

Withdrawal Rules:

- Ensure accurate banking details to avoid payout delays.
 - Earnings below ₦10,000 roll over to the next month.
 - **Tax Deduction:** All affiliate earnings are subject to applicable tax deductions as required by law. The final payout amount will reflect these deductions.
 - Promallshop reserves the right to withhold payments in case of fraudulent activities.

- ✓ Influencer marketing, product reviews, and content creation.

Prohibited Marketing Methods:

- ✗ Using false advertising or misleading promotions.
- ✗ Spamming affiliate links in unauthorized places (forums, comment sections, etc.).
- ✗ Bidding on Promallshop brand keywords in paid ads (e.g., Google Ads, Facebook Ads).
- ✗ Generating fake transactions or fraudulent referrals.

Violations may lead to **suspension or termination** from the program.

7. Affiliate Responsibilities

- Affiliates are responsible for **creating and sharing their promotions**.
 - Affiliates must not claim to be **official Promallshop representatives**.
 - Compliance with **local advertising and online marketing regulations** is mandatory.
