- **Follow platform-specific rules** (e.g., no unauthorized promotions on Facebook Ads, Google Ads).

Violations & Consequences:

Offense	Penalty
False advertising or spam	1st warning, then removal
Misleading pricing claims	Immediate removal
Fraudulent transactions	Permanent ban
